### Martin Luther King Day-January 15, 2024



Martin Luther King Day is observed on the third Monday of January each year. Born in 1929, King's actual birthday is January 15.

King was the chief spokesperson for nonviolent activism in the Civil Rights Movement, which protested racial discrimination in federal and state law. The campaign for a federal holiday in King's honor began soon after his assassination in 1968. President Ronald Reagan signed the holiday into law in 1983, and it was first observed three years later on January 20, 1986. At first, some states resisted observing the holiday as such, giving it alternative names, or combining it with other holidays. It was officially observed in all 50 states for the first time in 2000.

### Being Prepared for Winter Storms Shared by Sofia Blake Eastern Division AEF Chairman

Winter storms can bring extreme cold, freezing rain, sleet, heavy snowfall, ice, and high winds. These storms can cause transportation, heat, power, and communication disruptions. They also can close schools, stores, and workplaces. But, because a warmer atmosphere, holds more moisture, heavier snowfalls are more likely to occur. We can take action to prepare. Prepare now to protect yourself, your loved ones, and your home. Take immediate precautions if you hear these words on the news:

**Winter Storm WARNING**: Life-threatening, severe winter conditions have begun or will begin within 24 hours.

**Blizzard WARNING**: Sustained winds or frequent gusts of 35 miles per hour or greater, plus considerable falling or blowing snow reducing visibility to less than a quarter mile, expected to prevail for three hours or longer.

Other winter storm words to listen for:

**WIND CHILL Temperature**: How cold people and animals feel when outside. As wind increases, heat is carried away from your body at a faster rate, driving down your body temperature and making you feel much colder. The wind chill temperature is not the actual temperature but rather how wind and cold feel on exposed skin.

Winter Storm OUTLOOK: Winter storm conditions possible in the next two to five days. Stay tuned to local media for updates.

Winter Storm WATCH: Winter storm conditions possible within the next 36 to 48 hours. Review your winter storm plans and stay informed about weather conditions.

Winter Weather ADVISORY: Winter weather conditions expected to cause significant inconveniences and may be hazardous but not life-threatening if you are cautious.

### What Should You Do Before a Winter Storm?

### • Plan to Stay Warm

Stay warm indoors to prevent frostbite and hypothermia.

Before the winter season begins, make sure you can heat your home safely. Prepare your home to keep out the cold with insulation, caulking, and weather stripping.

Consider using an indoor thermometer or thermostat to monitor the temperature inside.

Plan to check on loved ones and neighbors to make sure they are staying warm. This is especially important for older adults and babies.

Drink plenty of warm fluids but avoid caffeine and alcohol.

Avoid travel if you can.

If you must go outside, plan to dress properly. Keep your nose, ears, cheeks, chin, fingers, and



toes covered in warm, dry clothing. These areas are the first to be at risk for frostbite. Wear layers of loose clothing, a coat, hat, mittens, and water-resistant boots. Use a scarf to cover your face and mouth.

### • Gather Emergency Supplies

Gather food, water, and medicine before a winter storm. Stores might be closed, and it may be unsafe to travel. Organize supplies into a Go-Kit and a Stay-at-Home Kit.

**Go-Kit**: at least three days of supplies you can carry with you if you need to go somewhere else to stay warm. Include critical backup batteries and chargers for your devices (cell phone, CPAP, wheelchair, etc.).

Stay-at-Home Kit: at least two weeks of supplies.

Ensure you have enough warm clothing, such as hats, mittens, and blankets, for everyone in your household. You may lose access to drinking water. Set aside at least one gallon of drinking water per person per day.

Consider having emergency supplies in your vehicle, such as a blanket, warm clothing, a first aid kit, and boots. Have a 1-month supply of needed medications and medical supplies. Consider keeping a list of your medications and dosages on a small card to carry with you.

Keep personal, financial, and medical records safe and easy to access (hard copies or securely backed up). Have a snow shovel and ice-melting products to keep your walkways safe.

### • Learn Emergency Skills

Learn first aid and cardiopulmonary resuscitation (CPR). Emergency services may be delayed.

Learn how to spot and treat frostbite and hypothermia.

Install and test smoke alarms and carbon monoxide detectors with battery back-ups.

Be ready to live without power, gas, and water.

Learn how to keep pipes from freezing.

Plan to Stay Connected.

Sign up for free emergency alerts from your local government.

Plan to monitor local weather and news.

Have a backup battery or a way to charge your cell phone.

Have a battery-powered radio to use during a power outage.

Understand the alerts you may receive:

A WATCH means Be Prepared!

A WARNING means Take Action!

Create a support team to help everyone stay safe in a disaster. Plan how you can help each other.

### Stay Safe

Use care with space heaters and fireplaces to prevent fires. Keep anything that could catch fire at least 3 feet (1 meter) from the heat!

Avoid using candles because of the fire risk. Use battery-powered lights and flashlights instead.

Prevent carbon monoxide poisoning. Carbon monoxide poisoning is common during power outages when people use other means to heat and cook. You can prevent carbon monoxide poisoning.

Only use generators, grills, and camp stoves outdoors and away from windows.



Carbon monoxide kills. If you start to feel sick, dizzy, or weak, get to fresh air right away – do not delay. To prevent carbon monoxide poisoning and home fires, never heat your home with a cooking oven or stove.

### Act Fast if You See Signs of Frostbite or Hypothermia

Frostbite is when a part of your body freezes. Your nose, ears, cheeks, chin, fingers, and toes often are the first affected. People may experience pain, numbness, and a change of skin color.

What to do for frostbite: Move to a warm place. Warm the affected area gently by soaking in the warmth water (NOT hot) until the skin appears normal and feels warm. Seek emergency medical care.

Hypothermia can kill you. It occurs when your body loses heat faster than it can produce heat. This causes a dangerously low body temperature. Older adults, babies, children, and people with certain health conditions are more at risk.

Shivering is one of the first signs of hypothermia; other signs include confusion, drowsiness, and slurred speech.

What to do for hypothermia: Seek emergency medical care right away. Move to a warm place. Remove any wet clothing and warm the body slowly.

### • How Can You Stay Safe While Driving?

Check your vehicle emergency supplies kit and replenish it if necessary.

Bring enough of the following for each person:

Blankets or sleeping bags.

Rain gear, extra sets of dry clothing, mittens, socks, and wool hats

Newspapers for insulation

Plastic bags for sanitation

Canned fruit, nuts, and high energy snacks

Warm broth in a thermos and several bottles of water

Bring your cell phone and make sure the battery is charged.

Plan to travel during daylight and, if possible, take another person with you.

Let someone know your destination, your route, and when you expect to arrive.

Before leaving, check the weather reports for all areas you will be passing through.

### • If You Are Stranded

Stay in the vehicle and wait for help. Do not leave the vehicle to search for assistance unless help is visible within 100 yards (91 meters).

Display a trouble sign to indicate you need help. Hang a brightly colored cloth (preferably red) on the radio antenna and raise the hood after snow stops falling.

Turn on the engine for about 10 minutes each hour. Use the heater while the engine is running. Keep the exhaust pipe cleared of snow, and slightly open a downwind window for ventilation.

Leave the overhead light on when the engine is running so that you can be seen.

Do light exercises to keep up circulation. Clap your hands and move your arms and legs occasionally.

If more than one person is in the vehicle, take turns sleeping.

Huddle together for warmth. Wrap yourself in newspapers, maps, and even the removable floor mats to help trap more body heat.



Watch for signs of frostbite and hypothermia.

Drink fluids to avoid dehydration, which can make you more susceptible to the ill effects of cold and to heart attacks.

Avoid overexertion. Shoveling snow or pushing a vehicle can cause a heart attack or make others medical conditions worse.

### Stay Safe

If you need to go outside, use extreme caution when driving or walking on ice.

Avoid damaged or fallen power lines. They can electrocute you.

Be aware of branches, trees, and ice that may fall.

Avoid overexertion when shoveling snow. Take frequent breaks and, if possible, work with a partner.

Use ice-melting products to keep your walkways safe.

Go to a public library, shopping mall, or warming center if your home becomes too cold.

### Take Care of Yourself

It's normal to have a lot of bad feelings, stress, or anxiety.

Eat healthy food and get enough sleep to help you deal with stress.

You can contact the Disaster Distress Helpline for free if you need to talk to someone. Call or text 1-800-985-5990.

Once you are physically safe, take time to ensure your family's emotional and financial well-being.

Stay safe – stay warm- and enjoy your winter in Minnesota or wherever your travels take you.

I am writing you today to ask when planning your budgets that you include donations to The American Legion Family Hospital Association. We need your continued monetary support to help assist our own members. Each and every year we are receiving more and more applications for medical assistance from within our membership, and thankfully we are able to assist the majority of these requests. This program is one where we can proudly say we are members-assisting-members. Can they count on you?

Eligibility of assistance requires you must be a member of the Department of Minnesota American Legion, American Legion Auxiliary or Sons of The American Legion, or a dependent as determined by the IRS. You must be a member in good standing for at least one year. Assistance can be as much as \$4,000.00 annually and is paid directly to the medical facility. Often there are also negotiations decreasing or completely eliminating the billing balances.

The American Legion Family Hospital Association is a 501(c)3 charity and charitable gaming funds may be used when making donations. The Association also receives twenty-five cents per member, per year, from the annual dues of all three organizations. Memorials and personal donations are gratefully accepted and make up a portion of our annual funding drive.

If you are in need of more information or applications you can contact Department Headquarters or any Board Member. Board Members are also available to speak to your members at Post, Unit or Squadron meetings, please feel free to call upon us.

**Membership and Revenue** ~ The Association is officially incorporated as The American Legion Family Hospital Association

and all members of Minnesota American Legion Posts, American Legion Auxiliary Units, and Sons of The American Legion Squadrons are members of the association. Revenue for carrying on the work of the association consists of money received from Post, Unit, and Squadron dues, donations, and interest from investments.

**Eligibility** ~ All members of the association and eligible dependents, regardless of their place of residence, are eligible for benefits provided by the association. Criteria for eligibility is established by the Board of Trustee and published in the American Legion Family Hospital Association Operational Manual.

**Financial Assistance** ~ Financial assistance is available to all eligible members of the association for payment of medical bills incurred for services provided by any duly licensed hospital or medical practitioner provided the need for financial assistance has been determined. Before applying for aid, veterans should take advantage of the services offered them by the government at Veterans Hospitals. The member's dependents should make all possible use of other available medical assistance programs.

**Exceptions** ~ The Association does not pay for transportation to and from the hospital (unless by ambulance), hotel-motel bills for anyone accompanying a patient unless an attendant is deemed necessary and authorized by the association, telephone bills incurred by the patient, personal service, dental work, eye wear, or hearing aids. The association does not give aid in the nature of a loan or pay credit card charges.

### **Procedure** ~ the applicant should:

- 1. Contact the Service Officer of the local Post or the County Veterans Service Officer in their area to obtain an application blank.
- 2. Complete the application.
- 3. Copies of final medical bills must be provided.



2024

Approved by the Department Executive Committee on Oct. 26, 2023

### **Pass the Veterans and Military Omnibus Bill**

The 2023 session produced the second Veterans & Military Omnibus Bill, and this action to separate our legislation has become a Minnesota precedent. Let's not step backward. It ought to be a regular expectation, like an agriculture bill, tax bill or transportation bill.

## Charitable gambling: Provide meaningful tax relief and reinstate bonus games and free plays

• Provide meaningful tax relief. Last session, lawmakers granted tax relief bringing the top-tier from 36 percent to 33.5 percent, a slim reduction. Charities want that level to be 25 percent but would accept 30. The corporate income tax rate in Minnesota is 9.8 percent. Why are charities being taxed so harshly in comparison? The funds charities raise largely go back into their local economies and the good causes they donate to provide a valuable safety net for the disadvantaged.

• Broaden the tax structure. Right now, once an organization reaches \$157,000 in

combined net receipts for their fiscal year, they already are at the top tier for monthly taxes. ACM and other organizations want to modernize the tier structure for the current economy. This, too, would provide some measure of tax relief. The other tiers presently are 25 percent for over \$122,500 accumulated, 17 percent for over \$87,500 accumulated and 8 percent for starting





off.

• Reinstate bonus games and free plays. Bonus games and free plays do not mimic slot machines in any way, and courts have ruled on this. What determines slot machines are variable prize structures, jackpots and unlimited bets — not bonus games or free plays. Besides, what's the difference between awarding a free play on a \$5 game or a \$5

prize? Nothing. The tribes only asked for removal of the open-all feature last session. Inserting additional language was a punitive action by some anti-charity lawmakers.

• Push back the enactment date by one year. This e-tab industry took 10 years to build, and the Legislature asked the gaming industry to revamp it in one year. That's not possible. What if by January 2025 there have only been four games approved? What if there are 25 games approved but they are all dull? Either way, gaming revenue crashes. There remains a lot to figure out in the next year. Move enactment to January 2026.

# Fix a property-tax exemption for Gold Star spouses and do not charge for vehicle registration

The present law, MS 273.13, Subd. 34(d), says the surviving spouse must file within two years of the death and must live in the home at the time of the death. The statute cites the DD-1300 Report of Casualty or the DD-2064 Report of Death as indicators.

This property tax exemption law discriminates against active-duty spouses and would help only Minnesota National Guard or Reserve spouses. Clearly, active-duty spouses

highly likely live on or near out-of-state bases when their spouses die in service to the country. When they return to Minnesota, they find they do not qualify for the Gold Star property-tax exemption.

This is not in the spirit of our state's support for veterans and their families.

We also would favor changing the law to allow the spouses to remarry and





retain the benefit.

Many states do not charge vehicle registration fees for Gold Star spouses (based on the DD-1300 or DD-2064). Minnesota should follow suit.

These people have made deep sacrifices on behalf of our federal, state and local governments, and this would be the least our state could do to thank them.

### **Modernize the Homestead Market Value Exclusion**

Currently, there are two levels of property tax exclusions. The first one is a maximum exemption of \$150,000 for veterans rated by the VA 70 to 100 percent disabled. The second level of exclusion is for 100 percent permanent total and disabled veterans at \$300,000.

We need to accommodate more veterans to be eligible for this benefit. Provide an exclusion for veterans rated 50 to 100 percent disabled at \$200,000 off their property tax values, and provide market value exclusion of \$400,000 for 100 percent-rated veterans.

Also, it should provide an inflationary-based increase. We support the removal of the equal or lesser value language for surviving spouses.

### Provide 100% property tax relief for posts of veteran service organizations

Many 501(c)(3) nonprofit organizations received property tax exemptions after qualifying through their county assessor and going through a three-year assessment review.

We desire Minnesota to give 501(c)(4) and 501(c)(19) organizations access to the same nonprofit property tax exemptions provided to 501(c)(3) nonprofits. This would halt an unfair treatment and reduce the disturbing trend of posts going under.

In that spirit, we desire congressionally chartered veterans organizations — because they have a federal requirement of reporting their volunteer and charitable efforts directly to Congress annually — to pay zero property taxes. There are a handful of states that provide this same benefit as a recognition of the good veteran service organizations do for their communities, and Minnesota needs to be among them.

As a side benefit, a zero-tax measure would clear up much of the confusion city and county assessors statewide have regarding veteran posts and tax laws.

### Amend a law to help our CVSOs receive important documents

Alter Statute 197.63 to include county veteran service officers in the list of entities of which "vital records" documents can be issued without a charge. This would save all kinds of "acting on behalf of" confusion at county recorder offices. Waive license fees on

hunting, trapping and fishing for all veterans

We favor the Minnesota Department of Natural Resources waiving fees for veterans who are Minnesota residents on hunting, trapping and fishing licenses.

We advocate for the Legislature to approve the result of this proposal, as it would likely increase net license revenue for the DNR by encouraging their family members to purchase



licenses and would give veterans the health benefits that come from being outdoors.

## Allocate proceeds from military/veteran license plates to the Support Our Troops License Plate Grant Fund

Proceeds from sales of the Support Our Troops license plates go into a grant fund managed by the Minnesota Department of Veterans Affairs.

However, proceeds from all the other kinds of license plates that recognize past military service, military decorations, veterans organizations or veteran status — there are about 40 total — go into the state's general fund.

Veterans tell The American Legion they would rather have money from any military/ veteran-themed license plates directed to the SOT Plate Grant Fund. They often decline to purchase those plates because the funds aren't directed toward veterans or made available to veteran service organizaations through the grant process.

### **Approve 7 new license plates**

- Jewish War Veterans. There are license plates for other congressionally chartered veterans organizations, but, strangely, not one for the JWV. It's time to fix this oversight.
- Military retirees. Minnesota ought to offer license plates denoting career retirees of any of the 6 service branches: Army, Navy, Air Force, Marines, Coast Guard, Space Force.

### Administrative: Update the personal needs allowance at Minnesota Veterans Homes

No new law is needed for this matter, but The American Legion is working with the MDVA to increase the personal needs allowance for veterans in the Minnesota Veterans Homes.

Presently, in a worst-case scenario, veterans are allowed to keep \$90 a month, and that has not changed in 30 years. For the sake of dignity, it's time to increase their allowance to reflect increases in the cost of living.

### Let's make Poppy Events a success in your community!

The red poppy is a nationally recognized symbol of sacrifice worn by Americans since World War I to honor those who served and died for our country in all wars. It reminds Americans of the sacrifices made by our veterans while protecting our freedoms.

Led by the American Legion Auxiliary, each year members of The American Legion Family distribute poppies with a request that the person receiving the flower donate to support the future of veterans, active-duty military personnel and their families with medical and financial needs.

Poppy Days have become a familiar tradition in almost every American community. The American Legion Auxiliary members know when they are asked. What is our most recognized symbol of the sacrifices of our military? The answer is POPPY! As we move through our Christmas and New Year holiday celebrations using poppies on our gifts, decorations and crafts, FEBRUARY is the perfect month to continuously keep our poppy in the public eye. With Freedom Day, Valentines Day and Presidents Day, February provides great opportunities to proudly wear a poppy every day.

Make Poppy Events a success in your community:

- Wear the ALA poppy proudly. That bright, red flower on your label is a visual, tangible, and steadfast example of respect.
- ➤ Help distribute poppies and tell everyone why. Place donation cans at work, and in local businesses.
- Include a poppy on Valentine cards and gifts for Inpatient and Outpatient Veterans in a Medical facility.
- Including poppies in flower arrangements, crafts and gifts, makes Valentines Day a happy celebration of Love with a Poppy.
- Share on Facebook what you are doing and how. Make sure to use our hashtags #PoppyDay and #LegionFamily. Media is your fiend; make good use of radio, TV, newspaper, and every electronic avenue available. The distribution of this bright-red memorial flower to the public is a big component of the ALA's Poppy Program, one of our oldest and most widely recognized programs. The poppy symbolizes the sacrifice made by our veterans, servicemembers, and their families. However, many people do not know how the funds received from poppy distributions may be used or where the money can go.

Poppy funds are used to support **THREE Major** national mission outreach activities. The **FIRST** mission outreach activity is the National Veterans Creative Arts Festival, which the Auxiliary has proudly co-presented for over 20 years. The **SECOND** mission outreach activity is to support aspects of the Honor Flight mission. The **THIRD** mission outreach activity is to support our servicemembers nationwide.

In the past only poppies made by veterans could be distributed by American Legion Auxiliary members. Now several new options are available to allow for creative use of the poppy as a symbol. Check out National Headquarters Pinterest page at <a href="www.pinterest.com/alaforveterans">www.pinterest.com/alaforveterans</a> with how to instructions on felt poppies, crocheted poppies, and a recipe for poppy cookies. These ideas provide our members with many opportunities to tell the poppy story and raise funds for our veterans, military, and their families. National approval is not required for wearing homemade poppies, only poppies with an "In Memoriam" tag are officially branded. When homemade poppies and various poppy images are used the poppy should be RED since it symbolizes the blood sacrifice for our freedom; however previous rules governing the number of petals, colors or leaves no longer apply. MAKING THE MOST OF OUR POPPIES: TIPS for making the February event a success in your community.



### 1. DISTRIBUTE THE POPPY SYMBOL IN NON-TRADITIONAL WAYS.

We are no longer limited to using crepe paper poppies, and poppy labels no longer have to include the calendar year. For many years, the Illinois American Legion has used a fabric poppy manufactured by a veteran-owned business. Although a different design and feel from the traditional red crepe paper poppy, the fabric flower is attractive, meets The American Legion's specifications, and is easy to assemble. ALA members also can distribute the poppy symbol in non-traditional displays such as poppy buttons, jewelry, T-shirts, crafts (like the ornament pictured here), or cookies.



### 2. WHAT SUPPLIED DO I NEED FOR NATIONAL POPPY DAY?

While National Poppy Day is still a few months away, now is a great time to prepare? If units wish to distribute the traditional crepe paper poppies, they will need to procure an adequate supply of poppies, either from veteran poppy makers within their department or from the American Legion Flag & Emblem Sales (<a href="www.emblem.legion.org">www.emblem.legion.org</a>), which is available for purchase in bundles of 25. To collect donations, ALA-branded cans are also available through Emblem Sales. Or make your own via <a href="www.ALAforVeterans.org/programs/poppy">www.ALAforVeterans.org/programs/poppy</a>.



### 3. USE SOCIAL MEDIA TO SPREAD THE WORD ABOUT YOUR EVENTS

A key factor to hosting a successful National Poppy Day is making the public aware of your events and activities. Here's an easy way to communicate the poppy message for everybody -social media. With the simple click of a button, you can share your National Poppy Day plans with all your followers! You can also request to join the national ALA Poppy Program Facebook group at www. Facebook.com/groups/ALApoppy. There, you and other American Legion Auxiliary members can share ideas, projects, and information about our Poppy Program!



### 4. I'VE RAISED THE MONEY....NOW HOW CAN THE FUNDS BE USED?

It's up to each American Legion Auxiliary unit as to where they want their Poppy Funds used, as long as the unit follows the Poppy Fund criteria, which you can view in the *ALA Poppy Program Guide at* <a href="https://www.ALAforVeterans.org/Programs/Poppy">www.ALAforVeterans.org/Programs/Poppy</a> (member login required). ALA units may also send their poppy money to their department headquarters earmarked for a state Veterans Creative Arts Festival, or units may send their poppy money to American Legion Auxiliary National Headquarters earmarked for the National Veterans Creative Arts Festival and just this year you can support Honor Flight in your area. # Department of Minnesota January 2024 Unit Mailing Risk and Compliance

Risk Aversion is about avoiding risk. If you ignore the risks, you may have loss of investment moneys, misuse of moneys, and theft of moneys.

Review your expenses and incomes at each of your unit meetings and remember to do an audit at the end of each fiscal year. Your audit committee should be made up of 3-4 people who can be professionals or non-member volunteers. You should have the bank statements, all the receipts and bills, and the checkbook with you to look at when doing the audit. When the audit is done, make sure there is a person appointed to file your 990. A copy of the filed 990 should be made and kept with the financial paperwork. Filing date of the 990 should also be given to the Secretary so that a notation can be made in the minutes.

Some units have their Post file their 990's which is fine, except don't forget to audit your accounts before you give the Post the go ahead to file for you.

Filing keeps units tax-exempt and eligible for grants and donations. Remember that when determining the value of donations if the donor has received something of value back for the donation, that received value needs to be deducted from the total donation received.

Units have up to five months to file their 990 after their fiscal year but I suggest that you do it as soon as possible so that you don't forget to file it.
