CALL FOR THE ONE HUNDRED FIFTH ANNUAL CONVENTION AMERICAN LEGION AUXILIARY Department of Minnesota

The 106th Annual Convention of the American Legion Auxiliary, Department of Minnesota, is hereby called to be held in Willmar, Minnesota July 10, 11 and 12, 2025, for the purpose of:

- 1. Electing Department Officers
- 2. Considering any amendments which may be proposed for Unit, District, and Department Constitutions
- 3. Electing delegates and alternates to the 106th National Convention.
- 4. Receiving reports of Department Officers, National Committeewoman, District Presidents, and Chairmen of Department Committees.
- 5. The transaction of such other business as may be brought before the Convention in conformity with the provisions of the National and Department Constitutions.

REPRESENTATION: (Article VI, Unit Bylaws) "Each Unit shall be entitled to two delegates at the Department Convention one of whom shall be the Unit President, plus one additional delegate for each 50 members or major fraction thereof whose dues have been received by the Department Treasurer 30 days prior to the meeting of the Convention for which they are elected. Each Unit shall elect its delegates. In addition, each Unit shall elect alternate delegates to serve in the absence of delegates. The delegates shall serve in the order elected before any alternate delegates and then the alternate delegates shall serve in the order elected." (Example: Units which have membership of 10 to 25 are entitled to 2 delegates, Membership of 26 to 75, 3 delegates; 76 to 125, 4 delegates, etc.)

The vote of each Unit shall be equal to the total number of delegates to which the Unit is entitled, provided there is a delegate from the Unit present to cast the vote. Alternates will have power to vote only in the absence of the delegate.

"To be eligible to candidacy for office or delegate to convention, a member must be a member in good standing." (Article VIII, Unit Bylaws.)

EXPENSES: The Convention expenses of Unit delegates must be borne by their Unit or by the delegates themselves unless they are Department Chairmen or members of the Department Committees, CREDENTIALS: Two (2) delegate and two (2) alternate cards are included in this mailing. Additional cards will be available for pick up at the Department Convention. The outgoing Unit President is the Chairman of your Unit's delegation. If she will not be attending the delegation she should elect a chairman of the delegation. It is best to have this done before the delegates leave home.

<u>ELECTION OF DELEGATES</u>: All delegates and alternates shall be elected at a regular Unit meeting or at a special meeting <u>called for that purpose</u>.

FROM THE NATIONAL CO/CHAIR OF THE AMERICANISM PROGRAM



History

1868 General John A Logan called for a day of remembrance; many observed on May 30, began as a day to remember who died in the Civil War. The first Decoration Day, Gen. James Garfield and 5,000 participants decorated 20,000 graves at Arlington National Cemetery.

1890 All Northern states had Decoration Day as an official holiday. Southern states honored the dead on separate days until after WWI.

1966 Federal government declared Waterloo, NY, the official birthplace of Memorial Day.

1967 Federal government officially adopted the name Memorial Day.

1968 Memorial Day became a federal holiday, officially designated the last Monday of May going into effect in 1971.

Traditions

Cities and towns hold parades-especially large ones in Chicago, New York and Washington DC. Visiting cemeteries and memorials.

Wearing a red poppy, a tradition that started with a poem from WWI.

Many take a weekend trip, throw parties and barbeque's as it is the unofficial start of summer.

Reason

Memorial Day is celebrated to honor and remember those who have died while serving in the U.S. military. It is a day of reflection and mourning, not a celebration in the traditional sense, but a time to acknowledge the ultimate sacrifice made by these individuals. Cemeteries throughout the country are adorned with floral arrangements on graves and flags flying. Many cemeteries adorn each grave of a veteran with a flag.

Many towns have services in the morning, culminating with the raising of the flag to full staff. Prior to noon, the flags are flown at half-staff. Did you know The American Legion prepares a speech that can be used on Memorial Day.

What are traditions you have on Memorial Day? My earliest memory is with my parents and grandmother spending the day going to cemeteries. I think each year we visited a new cemetery to visit the grave of someone we knew. All across the nation, people pause at 3:00 pm to offer a word of prayer for the deceased.

Veterans' Day, November 11, is to celebrate, honor and give thanks to those who are living and served our country in the military.

Armed Forces Day held in May honors those men and women who are currently serving in the military.







National Poppy Day supports veterans, honors the fallen



American Legion Family leads effort to keep all who served front and center heading into Memorial Day weekend.

The American Legion Family has called upon Congress to designate May 26, as National Poppy Day to expand awareness and provide support everywhere for all who have served and sacrificed in the U.S. armed forces.

The American Legion Auxiliary has been conducting a Poppy Program for many years and their members' raise over \$6 million annually to provide support for veterans, military service-members and their families.

By wearing this simple red flower, we show our support for veterans of generations to come.

American Legion Family members who plan poppy distributions and similar commemorations around May 26 and the week leading into Memorial Day are urged to use the hashtags #PoppyDay and #LegionFamily so activities can be shared on Facebook, Twitter and other social media channels.

The American Legion designated the red poppy as its official flower at the organization's second national convention, Sept. 27, 1920.

May is designated as Military Appreciation Month, a time to honor and express gratitude to those who serve or have served in the United States Armed Forces, including their families. This month-long observance, established by Congress in 1999, aims to raise awareness and encourage celebration of the sacrifices made by military personnel.

Raising Awareness:

Military Appreciation Month helps to educate the public about the challenges faced by the military community and the importance of their service.

Celebrating Military History: May is also a time to remember and honor key events in military history, such as Loyalty Day, VE Day, and Memorial Day



MN Membership Member-opoly Report

Minnesota has a hefty membership goal of 26,014 members. On the National membership report of 5/14/25, Minnesota reported 23,190 members. This number is 876 members short of where we were a year ago. Membership is still trickling in, but not at a rate we need to meet the goal.

This is also the time of year when our snowbirds are returning home from their warm roosts. It is a great time to reach out to any of them that may not have paid their dues yet. Give them a quick call or send a card and ask if everything is going ok. Do they need a little help paying for their membership this year, or did they simply forget.

Take a peek at 'your' individual units, see where you are today and where you were last year at reporting date; if not using ALAMIS, wait, wait...(everyone should be using ALAMIS) it's a great tool for membership, ok so if not using ALAMIS - cross-reference transmittals to ensure all are processed accordingly. Has everyone that you sent in for processing been processed?

One of the things that I have come across while doing membership this year is that when I reviewed membership rosters and went through the names, especially the PUFL or HLM's, I found many deceased members on the roster. Each unit needs to have due diligence in maintaining their membership lists to ensure if the member is deceased, we report it to the Department Office.

Looking over the year, we had one new charter started this year, but many, many charters disbanded.

If your Unit is looking at disbanding, please reach out to your Department Membership Chairman, your District President or the Department Office. Anyone of these people can give you the information that you will need to make an informed decision about this. We would like to talk with your unit on the options your unit has. We don't like closing charters. There is a procedure that must be followed to close a charter. This is not a decision that an individual can make.

If you are considering disbanding due to 990 non-compliance issues, explore the possibility of getting your tax-exempt back under the national ALA group exemption number. This should be a no cost method to bring your Unit back into compliance, there will be paperwork involved in this process.

It has been exciting working as your Membership Chairman this year and I hope we continue finding ways to increase our membership.
