I received this information from our Northwestern Legislative Chairman Gayla Schmid and she wanted me to share with our District Chairman and with our members.

The legislative program is to maintain communication between your Senators and Representatives on both State and National levels to help the American Legion in their legislation. The information to them and to our members on important issues concerning, veterans' benefits, families of our veterans, and for the disabled veterans.

By calling, writing, or emailing our representatives in our State and National Government we can a vote, from negative to positive. To let them know we are supporting our veterans and the issues they face.

There are so many ways you can help our Veteran's this is just one way but maybe the most important way to help. At National Convention, our President Donald Trump signed the "Veterans Appeals Improvement and Modernization Act of 2017".
